The Board is going to conduct the 1st, 2nd & 3rd (Last) Round of online Counselling for admission in different branches of B.E./B.Tech. course of Govt. recognized engineering institutes of Jharkhand State.

2. First (1st) Round of online counselling will be conducted on the basis of State Merit List published on 16.06.2025. Candidates having applied for inclusion of their names in State Merit List for the First Round of Online Counselling need not fill the online application form for the subsequent rounds of Counselling.

4. Candidates are advised to fill as many preferences as possible for Institute/Institutes and Branch/Branches in which they are interested to take admission, for securing seat allotment as per their merit –cum-choice.
5. **Candidates, who have been recommended for admission, will have to submit all concerned original certificates/documents as per their seat allotment, failing which their Provisional Seat Allotment Letter will be deemed cancelled.**
6. Candidates who are admitted on the basis of 1st and/or 2nd round of online Counselling and want to change branch and/or institute against the remaining vacant seats can appear in 2nd and/or 3rd (final) Counselling respectively. If the seat is re-allocated in the concerned Counselling/Counsellings, it will be mandatory for the candidate to get admitted in the newly allotted branch and/or institute as their earlier admission will automatically be cancelled and the seat thus vacated will be allotted to another candidate on merit-cum-choice basis by the Board.
7. **Registration/Application & Counselling Fee:-**Candidate will have to pay Registration /Application & Counselling Fee through Payment Gateway by Credit Card/Debit Card/Net Banking/UPI as given below:-

8. (a) The Partial Admission Fee being taken previously has now been replaced by the Security Deposit as per direction of Directorate, Technical Education Higher & Technical Education, Govt. of Jharkhand vide Letter No. DTESec/JCECEB-2/2020/HTESD-680 dated-26.06.2023. The Security Deposit will be later transferred to institutes for adjustment in the prescribed admission fees of the admitted candidates.
- (b) In compliance of the above letter, the candidate will have to pay the Security Deposit as per the following extent:-

1	ST/SC/Female of all categories	2000.00
2	BC-I/BC-II/EWS	3500.00
3	General	5000.00

(c) The Security Deposit will be refunded if the candidate relinquishes/vacates allotted seat before the last round of counselling. If the candidate does not take admission after last round of counselling or does not wish to continue after admission, the Security Deposit will be forfeited.

(d) In case, the candidate fails to take admission despite being recommended twice for admission during counselling, the Board will forfeit the Security Deposit.

9. The vacant seats under different category/categories will be exchanged in Third (Last) Round of Online Counselling as per the provisions of Department of Personnel, Administrative Reforms and Rajbhasa, Govt. of Jharkhand in case of unavailability of reserved category candidates.
10. Security Money deposited by the candidates at the time of counselling, will be refunded to the candidate and/or the institute within three months after the end of last round of online counselling.

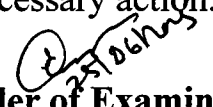
